- 1) Using the "Print" Button below, please print at least one copy of this Entry for your records. You must do this BEFORE you submit the form. to retain a copy for your records.
 - 2) **Save a copy to your hard drive. Use the "Save" icon on your browser to save.**
 - 3) Use the "Submit" button above (it will not work if you are not in Adobe Reader). You will be asked what type of email program you use: Desktop (Outlook, Thunderbird, etc) or Web - based (hotmail, gmail, etc).
If you use Desktop email – an email with your application attached will be put into your outgoing mail file. We recommend you go there, open the file, turn on the "Read Receipt" (Options, Read Receipt). Your Read Receipt is your confirmation that your entry was received. Then, click "Send". Your email will not be sent until you send it or it automatically cycles through its setup process to send.
If you use Web Mail – you must create an email to carol@artaffairs.org with the subject "Garment Entry" and attach your saved pdf application to it. We recommend you request a Read Receipt, if you are able. The Read Receipt is your confirmation that your entry was received.
 - 4) Please send entry fee (\$10/ea or 3 for \$25) to the Midwest Fiber & Folk Art Fair:
By credit card: Return to www.fiberandfolk.com/garment.htm and use the "Add to Cart" Buttons for the \$10 or the \$25. If you are entering 2 pieces, adjust the number of \$10 items as you check out.
By check: Make check payable to Midwest Fiber & Folk Art Fair and send to address above. All fees must be postmarked by **July1, 2014**. This is a hard deadline. We need time to do a good job for you!
 - 5) Email images of your entries (see Prospectus) to Carol@fiberandfolk.com with the subject "GARMENT ENTRY".
 - 6) You will be emailed your information packet after July 15, 2014.
